## **Recommend Approval of Courtyard Stair Replacement**

Recommend the Luzerne County Community College Board of Trustees approve the award of the Courtyard Stair Replacement project bid to the lowest responsible bidder: Panzitta Enterprises, Inc. in the amount of \$318,600. In addition, the architect and engineering fees payable to hemmler + camayd architects, in line with the agreement in place (7.99% for this project cost) in the amount of \$25,456.14 will be incurred. An 8% contingency fee - \$25,488 for the contractor and \$2,036.49 for related architect and engineering services – could be incurred, for a total project cost of \$371,580.63.

The 8% contingency is not a definite expenditure; however, available if necessary. If it is not utilized as part of the project, the funds will be returned to the available funds for other projects.

## **Rationale:**

There are four sets of exposed exterior concrete stairs that have incurred significant damage due to age and weather conditions. These stairs are not covered with canopies as some of the other stairs throughout campus. The last winter was especially rough on the concrete as the rain and snowmelt would get into the cracks and then freeze which caused the steps to break. Our physical plant team has repaired the stairs however; they are now in need of being replaced. This has become a safety issue that we wish to address with the available funding.

We originally bid this project at the beginning of the 2022 summer however there was only one bid received and, due to the costs associated, we wanted to explore several options to adequately address the stairs in the safest way while being financially responsible.

Alternatives were provided in the re-bid. Those alternatives included: a base bid of the full replacement of the stairs, side walls, and all railings; alternate #1 to remove and replace the stairs and center handrail, and address the sidewalls (which are structurally sound and only need to be cosmetically addressed); and price per set of stairs in case there was a possibility of not replacing all of the sets of stairs identified at this time.

The College was able to allocate Bookstore Cash Reserve funds for prioritized projects, which includes the Courtyard Stair Replacement. The College uses the budget process to identify and request necessary infrastructure replacement.

The 8% contingency is not a definite expenditure; however, available if necessary. If it is not utilized as part of the project, the funds will be returned to the available funds for other projects. The College uses the budget process to identify and request necessary infrastructure replacement.

## RE: Courtyard Stair Replacement

Our architectural and engineering consultant firms, hemmler + camayd architects and GPI respectively, prepared bid documents that were advertised on Monday, July 11, 2022. There was a mandatory prebid meeting held on Tuesday, July 19, 2022, and bids were opened on Tuesday, August 2, 2022.

There is one (1) contract associated with this bid. Four (4) general contractors attended the mandatory pre-bid meeting on Tuesday, July 19, 2022. Three (3) bidders submitted on August 2, 2022. The College determined the best course of action is to select Alternate #1 – to remove/replace the stairs and center handrail, and address the sidewalls (which are structurally sound and only need to be cosmetically addressed) which resulted in the following:

Hemmler + camayd architects and GPI have reviewed the bid packages and found the required information to be in order. We recommend awarding the bid to the lowest responsible bidder: Panzitta Enterprises, Inc. in the amount of \$318,600. In addition, the architect and engineering fees payable to hemmler + camayd architects, in line with the agreement in place (7.99% for this project cost) in the amount of \$25,456.14 will be incurred.
