# 8A Recommendation to Approve Board Resolution - PDE Capital Application Projects

Recommend the Luzerne County Community College ("LCCC") Board of Trustees approve the capital projects to be submitted in March 2023 via the Pennsylvania Department of Education ("PDE") capital application process. Additionally, Luzerne County Community College Board of Trustees approve the authorization of matching funds for any capital project submitted via the PDE capital application process and approved for funding by PDE for FY2023-2024.

The capital projects, in priority order, approved to be submitted to PDE in the March 2023 capital application process and the estimated costs are:

- Water Line Replacement \$300,000
- Roof Replacements on Five (5) Campus Buildings \$3,200,000

Final Board of Trustees approval of the project(s) will be submitted with exact funding amounts when approved for funding by PDE. All College policies and procedures will be followed.

# 8B. Recommend Approval of Ground Lease Agreement with the City of Nanticoke

Recommend the Luzerne County Community College Board of Trustees approve a Ground Lease Agreement with the City of Nanticoke for their Department of Public Works (DPW) Facility to be located on land owned by LCCC. The terms of the lease shall begin upon execution of the Ground Lease Agreement and expire on the ninety-ninth-year anniversary unless sooner terminated. The rent shall be in the amount of \$1.00 per annum and can be prepaid at any time.
