President's Report Treasurer's Report	President Leary began his report by noting, on Tuesday, October 19 <sup>th</sup> , 2021, a Ribbon Cutting ceremony was held to celebrate the 20 <sup>th</sup> Anniversary of the Luzerne County Community College Hazleton Center. The program included remarks presented by Board Chair Rodgers, Kim Whalen, Director of the Hazleton Center, Rosana Reyes, Vice President of Enrollment Management and Student Affairs, as well as LCCC student representatives and business leaders. A tour of the Center and it's new MAC computer lab and science lab demonstrations were included. The College also announced a new Communication Arts programs offered at the Center in Web Design and Digital Design. In conjunction with the celebration, an open house was held for the community. The MAC computer lab is important with respect to the College's initiative to provide micro- credentialing which will prepare individuals with short term training is an initiative that the College is further enhancing in other programs The new Science lab will provide students the important opportunity to begin their pursuit with admission into our Health Science programs including Nursing, Respiratory Therapy, Surgical Technology and Dental Hygiene. President Leary introduced Sue Spry, Associate Vice President of	
Academic Affairs, who provided an update on the College's CDL	
program.

Associate Vice President Sue Spry stated there are few other industry credentials that individuals can achieve after a short training program that has the economic impact like a Commercial Driver License ("CDL"). Since the 1980's the College has offered a CDL; over last few years the College partnered with CC Training to deliver the instructional component of the program. The classes for CDL run Monday through Friday, 7:30 a.m. to 5;30 p.m., and complete in a 4-week period. A weekend program is offered on Saturday and Sunday, those students complete the program in 9 weeks. The majority of the program is hands-on training spending three weeks on the range (PSTI), on road, surface streets and highways. Students receive the CDL exam as part of the course and leave the course as a Commercial Drivers' License holder. Placement rate is approximately 88% which goes up approximately 6-months after the student takes the exam. Recruiters offer sign-on bonus and other quality of life benefits. Women are also being sought as well as other diverse populations. The classes only allow 8 students; and the College is seeing 1-3 women in each class. We produce 125 CDL graduates throughout the year but it is nearly not enough for the demand for CDL holders. The demand for CDL drivers is expected to increase by 6% each year up to 2030. Our CDL program is exemplary; the range of programming we provide at Luzerne County Community College from short term training to the Associate level, many students go beyond the associates' level. A big part of the mission at the College is around access to programing; and the CDL program is very accessible to a diverse range of students regardless of their academic preparation. <ul> <li>Foundation Report</li> </ul>	<ul> <li>Rebecca Brominski, Executive Director of Institutional Advancement remarked that the past few weeks have been very busy for LCCC Alumni Association and Foundation.</li> <li>On Saturday, October 16<sup>th</sup>, the Alumni Association welcomed hundreds of guests to the 32<sup>nd</sup> Annual Craft Festival, raising an all-time high of \$14,000 that will support student scholarships as well</li> </ul>	
	as alumni community outreach. Last week the Foundation welcomed over 250 community leaders and donors to the 29 <sup>th</sup> Annual Scholarship Celebration – this event allows our student scholarship recipients the opportunity to meet their donors. To date we have raised over \$70,000.	
	To wrap up the week the Foundation celebrated the 15 <sup>th</sup> anniversary of the Schulman Gallery. The evening welcomed over 130 guests and concluded with Roxanne Schulman announcing the establishment of a new scholarship honoring the legacy of Mrs. Schulman's late husband Dr. Norman Schulman. The Dr. Norman Schulman Scholarship will be awarded in the Fall 2022 to a Communication Arts major.	
	This November the College will celebrate the 5 <sup>th</sup> anniversary of the Peter J. Lello Student Food Bank. Since its inception the Food Bank raised over \$50,000 in addition to the thousands of in-kind donations of food, personal items, warm weather clothing and baby items for our students and their families.	
	As part of the celebration, the Foundation partnered with the Askam United Methodist Church in providing complete Thanksgiving meals for our LCCC students and their families. Everyone can participate in this program by adopting an "LCCC Trailblazer" by donating \$40 to the LCCC Foundation. We are hoping to match the 25 meals that have already been donated by the Askam United Methodist Church. It is our hope to feed a total of 50 families.
