Recommend the Luzerne County Community College Board of Trustees approve the Curriculum Additions, Deletions, and Modifications as attached.

8A. Recommendation to Approve Building 5 Handrail Replacement

Recommend the Luzerne County Community College Board of Trustees approve the award of the Building 5 Handrail Replacement project bid to the lowest responsible bidder: Minichi, Inc. in the amount of \$25,500. In addition, the architect and engineering fees payable to hemmler + camayd architects, in line with the agreement in place (9.99% for this project cost) in the amount of \$2,547.50 will be incurred. An 8% Contingency fee (\$2,243.80) for the contractor and related architect and engineering services could be incurred for a total project cost of \$30,291.25.

8B. Recommendation to Approve RFQ for CDL Instruction and Training

Recommend Luzerne County Community College Board of Trustees approve the proposal that Fortis Institute be awarded the contract to complete the training and testing for the 18 students whose CDL instruction was interrupted by Luzerne's discontinuation of the contract with its prior CDL instructional provider. Fortis will complete the training at a cost of \$2,500 for the weekend CDL students and \$3,000 per student for the Monday-Friday class. The difference in cost per student reflects the estimated amount of training that remains to be done.
