

## SUMMER II 2024 IMPORTANT PAYMENT INFORMATION <u>Tuition Payment Deadline</u> -- Monday, June 17, 2024

<u>Tuition and Fee</u> billing is an automated, electronic process driven by student registration transactions. All student account information and billing statements are available electronically through Self-Service. Notifications of e-statements are issued to the student's official College email. Students are required to monitor their school email account regularly.

**Summer 2024 course registration creates financial responsibility for tuition and fees.** Financial clearance of your student account must be achieved by the tuition payment deadline through one or more of the options listed below.

Registration will be accepted after the payment deadline; **payment must be made at the time of registration (unless charges are** otherwise covered by one of the options listed below). If you choose not to take class(es), you must officially drop your class(es). Please refer to the <u>College Catalog</u> or contact the <u>Registrar's Office</u> for information on how to drop classes or withdraw. You should also refer to the <u>College's Official Refund Policy</u> for details on refunds for dropped courses or complete withdrawals during the refund period. Please note that if you do not drop your class(es), you will remain responsible for all charges!
